# Value & Services



### Prior to commencement D&S Civil is able to assist with site setup, including;

- Setup of office blocks, toilets and dongas
- Setup of turkeys nests and stand pipes
- Welding and running HDPE water lines
- Removing existing rock from culverts
- Assistance with culvert mounds
- Clearing (IT loaders have scrub rakes)
- Organising lay down areas (for pipes and workshop)
- Unloading incoming trucks
- Setup of concrete pads for workshops, including jacking pads



### Additional services throughout may include:

- Making rock, breaking rock in cuts
- Sorting out design changes with client
- Adjusting levels to suit creeks
- Constructing rail loading ramps
- Installing concrete margin beams
- Installing rock on floodways
- Loading and/or driving moxies, driving rollers
- Pulling batters
- Digging drains
- Load out windrows (loaders have cutting edges, not teeth)
- Installing electrical and communications
- Installing sewer lines, storm water and water mains
- Site clean up



# Projects



## GUDAI\_DARRI NORTHERN RAIL PACKAGE

Gudai-Darri (Koodaideri) Northern Rail Package consisted of approximately 33,500m of polymer coated CSP culverts, along with two locations of 3m x 2.7m concrete box culverts, to be installed over 100km of new rail formation. Culvert sizes ranged from Ø600mm to Ø2100mm with as many as 55 barrels being installed at one location. The project also consisted of over 27,000m<sup>2</sup> of rock protection aprons.



## IRON BRIDGE MAGNETITE

Contracting to NRW to help with the successful installation of critical concrete works, large diameter Reinforced Concrete Pipes, rock batters, as well as approximately 2,200m of CSP Culverts. Then Contracting to Whittens under FMG's direction, to help complete the Slurry Transfer Pipeline from Mine to Port.



## CHRISTMAS CREEK HALL HUB PROJECT

Contracting NRW for the Christmas Creek Hall Hub Project, D&S were responsible for culvert installation, site float movements, rock protection works, and underground fibre optic and power services. 6,400m of large diameter multi-barrell CSP culverts were installed in less than 5 months.
